(A) Posts No. 01 to 21 :

- (1) It is **strongly recommended** to use a Laptop/Desktop/Notebook PC based browser to fill/submit your **On-line Application** to avoid unforeseen errors related to browser. Especially, please avoid on-line application/entries using Mobile based browsers.
- (2) Name of the University (including that of Foreign Univ.), if not available in the drop down list, shall be added in due course once pointed out to SAC. Kindly note that the candidates are required to furnish details of the University. (Name, Affiliation and link of the website of University).
- (3) The kind attention of the candidates, possessing Degrees awarded by foreign universities, is drawn towards para-9 under "Note/Important Information" section of the detailed advertisement (on pages-11&12), which is Self-Explanatory.
- (4) Kindly note that if your university declares the result in terms of percentage, criteria of percentage shall be applicable and if your university declares the result in terms of CPI/CGPA, criteria of CPI/CGPA will be applicable.
- (5) CGPA/CPI grading **on a ten scale** is required to be entered in the On-line Application. Applicants possessing Foreign Degrees may suitably convert/scale the CGPA/CPI grading.
- (6) The candidate must possess the essential and Pre-Requisite/s qualification prescribed for the post. The candidate may go through the detailed advertisement available on SAC website for these details. **Further Specific Clarifications related to Pre-Requisite/s and Essential Qualifications, are provided below, for respective posts.**
