- v. Please get individual/specific Guidance/Help from any of the ETF team members by contacting them on phone/mobile on the following aspects:
  - Covid-19/CHSS related Info. through Aakash and Vyom Websites
  - Selection of suitable health Packages for the patients
  - Patient Accommodation in local Hospitals / Transit Facilities
  - Getting Ambulance/Transport of Patients for Investigation/Hospitalisation
  - Getting Medicines, Oxygen, Food for Patients / Affected Families
  - Coordination with CHSS Empanelled and Other Hospitals, Ahm. UHC etc.
